  - o using natural resources (such as water) and raw materials rationally;
  - o reducing the production of waste by facilitating reuse and recycling of materials;
  - o reducing emissions of any pollutants;
  - reducing emissions of CO<sub>2</sub> and all other greenhouse gases to mitigate climate change impacts (also encouraging energy efficiency improvements and, where sustainable, usage of renewable energy);
- develop production approaches that favour energy efficiency through the application of the best management and technological solutions;
- define the objectives aimed at improving energy performance and ensure adequate information and resources for their achievement, carrying out constant monitoring;
